- 4. That applicant/owner is limited to what is noted in the application and any intensification of operations will require a new conditional use application.
- 5. That the hours of operation are limited to 8:00 a.m. to 8:00 p.m. to respect the peace and harmony of surrounding residential inhabitants.
- 6. That this conditional use order is valid for a five (5) year term at which time the applicant must apply for a new conditional use order.
- 7. That there is to be no outdoor storage of business-related materials.
- 8. That no signage be erected to advertise the business.
- 9. That the business has no more than 4 employees.
- 10. That the business operates in compliance with all municipal by-laws.

# 3.2 Road Opening – Lot 1 Plan 14410 in NE <sup>1</sup>/<sub>4</sub> Section 11-13-6EPM

NE <sup>1</sup>/<sub>4</sub> Section 11-13-6EPM as condition of approval for subdivision File No. 4110-21-7583.

Chief Administrative Officer Sue Sutherland reviewed the Road Opening process as condition of proposed subdivision. The applicants, Lidiya and Johann Ikkert, were in attendance to speak in favour of the road opening.

Janet Piirik spoke in opposition of the road opening as she does not want an increase in traffic, the road would be too close to her garage, she is concerned about drainage and the effect it could have on resale value of her property.

Kim Sitch also spoke in opposition to the road opening. She listed the required standard widths for various roads and cul de sacs and compared them to the proposed widths of the road to be opened. She was also concerned with the lack of sidewalks, as Gillis School is further south on Pierson Drive. Sue Sutherland stated that a 66 foot road allowance is permitted under the Municipal Standards.

David Sitch spoke in opposition to the road opening stating that the traffic traveling west will be shining headlights into the front windows of his house.

Christopher Harrison spoke in opposition questioning the drainage at the new road and his property line. He also expressed concern with traffic control on Pierson Drive. He has tried calling the RCMP, but they will not send anyone.

Yvonne Moroz-Harrison also spoke in opposition to the road opening, expressing her concern with the Local Urban District of Tyndall-Garson water and sewer system and their capacity to service new residential lot. The engineers have stated there is no issue with a development this size at this time.

Kim Sitch also addressed that proposed Lots 3-7 are 73.6 feet wide, not the minimum 75 feet as required. Sue Sutherland explained that the Brokenhead River Planning District can do in-house variations for up to a 10% difference. Also all total site areas meet the criteria.
